Treasurer's Report: Leonard Zumstein has completed and emailed Forms #28 and #29 to the appropriate recipients. The APRIL 2023 report includes a bank balance of \$4,716.71 and cash on hand in the amount of \$275.00 for a total checkbook balance of \$4,441.71. Our 4/19 /23 luncheon sales were \$1,037.00 and luncheon expenses were \$1,057.00 for the caterer, \$275 (Denair Community Center). For the 5/17/23 meeting, Larry Hughes was paid \$23.24 (tablecloths); Bob Holly was paid \$35.23 for purchase of (Punch/Tea and Ice).

The Treasure's report was passed unanimously with a 1st by Joe Adams and 2nd by Greg Back

Secretary's Report: The minutes of the APRIL BEC Meeting were unanimously approved as emailed and printed in the Newsletter with a 1st by Greg Back and 2nd Larry Hughes.

Committee Reports:

Membership Report Form 27 was filed, by Larry Hughes: Larry reports 37 Members present at our May luncheon. We had 7 guests and two speakers. Visiting SIR members 0. There were 60 members absent. The Membership report was approved unanimously with a 1st by Greg Back and 2nd by Joe Adams.

Golf report -Joe Adams: Joe reports Golf staff will be qualified in Manteca. We will be guaranteed 2 members to go to state.

Travel – John Cardoza is absent. Nothing to report. **Bocce Ball:** Mike Johnson: First and Third Fridays at 11:00 a.m. at Dustbowl

Dine in/Out - Gary Toombs absent. Nothing to report.

Old Business: Discussion:

There was ongoing discussion about a need to make decisions about the cost of future SIRS luncheons based on the overall costs we are now incurring for said SIRS luncheons, (catering costs, hall rental and the purchasing of other supplies. THE WINE LINE

Livin' the Dream in SLO Wine Country

Eric Johnson grew up on a farm in Los Banos where his family grew apricots and raised sheep and pigs. His roommate at Cal Poly San Luis Obispo came from a wine growing family in Sonoma. While visiting there Eric's interest in wine and winemaking was sparked. He began his career by working in the tasting room at Bianchi Winery in Paso Robles. In 2007 he joined the tasting room crew of Talley Vineyards and the same year he was chosen as a harvest intern.

In 2010, Brian Talley, President of Talley Vineyards, announced the appointment of Eric Johnson as the winemaker of Talley Vineyards. In his statement to Wine Business News, Talley said "Eric's commitment to quality, his enthusiasm and his handson-leadership style are a real inspiration to our entire team." To move up from a harvest intern to winemaker in three years is incredible, and at just 26 years of age. During our interview with Eric, in Talley Vineyard's beautifully remodeled tasting room, we witnesses that same enthusiasm even after 13 harvests.

His philosophy of winemaking is to grow quality grapes, pick at just the right time, use only native fermentation and then to let the grapes do their magic. Quality grapes will make quality wines and will reflect the terroir. His favorite time of the year is the harvest. He gets up at 2:00 am and meets his night picking crew. I call that hands-on-leadership.

When asked about the new releases he said the 2021's are coming out and are similar to the 2019's. They are fresh and energetic. The Stone Corral Pinot Noir, which is already released, is delicate. The Rincon and Rosemary's will be released in about two months. The 2022 Rose of Grenache is out and delicious. It will definitely be a sell out.

In 2015, Eric and his wife Cait started their own label, Ann Albert Wines. They make two Chardonnays and a Gamay. Production is about 400 cases and is sold locally and through a broker in Los Angeles.

I asked him what he envisions for the future. Eric said he loved his family, now with a daughter, his home in San Luis Obispo, the ability to walk to Cal Poly games, his easy commute, the Talley family and all their employees. His response was "I love my job!" He is obviously Livin' the Dream in SLO Wine Country.


