## Future of SIR Consensus Vote

- 1) Emphasize the name SIR when addressing potential recruits, and in other recruiting opportunities. <u>Consensus is Yes.</u>
- 2) Focus SIR recruiting materials on two mottos that capture the nature of SIR "Make Friends for Life" and, "We are SIR, the activity club for men". The consensus is No. The Branch agrees the Making Friends for Life should be part of our mission statement but reject the idea that we are only an activity club for men. As one member put it," "We are an organization that facilitates a variety of group activities where friendships can be formed.
- 3) Strongly encourage Sirs when they are volunteering in the community as individuals to wear Sir apparel to bring recognition that SIR is helping. **Consensus is Yes**

- 4) (A) Encourage Branches to establish more coed activities (a target might be 50 percent of Branch activities). AND: (B) Build recruiting alliances with women's and other organizations at the State and Branch level. **Consensus is Yes**
- 5) Encourage Branches to offer additional activities that support physical health and fitness as well as educational activities/opportunities to stimulate the mind. Consensus is Yes but with the stipulation of reaching out to the State College system as well as Community Colleges
- 6) Branches are to retain the current "five meeting" rule unless the Branch BEC elects to set their own attendance rules. Consensus is Yes
- 7) Eliminate inactive and emeritus status, and allow those members missing meetings to remain SIR members. Allow Branches the flexibility to accommodate those members who are unable or dislike attending meetings to remain SIR members. Consensus is Yes
- 8) Encourage member surveys, be they formal or informal, as surveys are critical to ensuring long-term member satisfaction. **Consensus is Yes**
- 9) Better match our ethnic mix with that of the community recruited **Consensus is Yes**
- 10) Be frugal. Consensus is Yes but the State needs to do more to reduce their expenses. Our Branch expenses are tied to the State expenses
- 11) (A) Encourage all levels of SIR to tap into the capabilities of Sir's younger and newer members AND (B) Term out directors after three years unless participating in a succession program to gain branch leadership experience. Approval for non-compliant actions may be granted by the Region Director, or the President in the Region Director's absence. Consensus is Yes for part A BUT No for part B. Terming out Directors should be a Branch decision.
- 12) Significantly reduce the words retirement, senior, and other ageist language from our external communications. The consensus is a strong No to this proposal. Many of our newer members have joined SIR because it is a retirement focused organization.
- 13) Recruit "men just sitting around home" as SIR can significantly improve their lives they are a ready-made market for us. **Consensus is Yes**
- 14) Allow more flexibility at the branch level -to simplify their operations and define the minimum requirements that need to be met. **Consensus is Yes**
- 15) (A) Refrain from expending resources on failing branches that do not want to improve. Instead, help branches that want to improve AND (B) Explore opening new Branches in high opportunity cities. Consensus is No to part A. We should continue to work hard to save failing branches using as many resources as possible. Consensus is Yes to part B.
- 16) Provide State Chairmen of key committees a stronger voice at the State Board. Consensus is Yes as long as they remain non voting.
- 17) Develop an SIR Business Plan. (3 Year) Consensus is Yes
