Improvement in the 2018 Membership trend

The latest 12-month rolling membership report available on the State website (http://sirinc.org/MemInfo/MembershipStatistics/ActLst12ByBrnch_20181220.pdf shows a membership count of 13,563 as of November 1st which is a loss of 248 members since November 2017. This loss is -1.8% which is a great improvement over the multi-year average of around -4%. This improvement is due to the hard work of Branch Leadership assisted by your Area Governors and Regional Directors. Let's challenge ourselves to do even better in 2019 - can we break even or better yet, grow just a little?

Fundraising for the Sir victims of the Camp Fire in and around Paradise

As I write this message on December 31, I am pleased to report that so far we have raised \$33,553, but this is not the end. We are asking Branches to continue their lunch meeting collections through at least February. I'd also like to suggest that Branches continue to explain the situation to their members via information in both their monthly newsletter and on their website As an example see what Branch 98 says on the front page of their website at https://sir98.org/ and on page 6 of their January 2019 newsletter, The Rooster Tale. Please continue your fundraising actions so we can offer more to our Friends in Branches 52 and 135 who have lost so much. Thank you.

The total so far comprises \$13,553 collected through the GoFundMe website, plus \$20,000 collected via donations at Branch luncheons. These funds will be paid into a bank account set up by The Sons In Retirement Foundation (SIRF), a new non-profit which is being set up to distribute the collected funds.

The Foundation is being created as a 501(c)(3) non-profit organization. To make this happen we have to register the name of the Foundation with the Secretary of State for California, obtain an EIN number from the IRS, register with both the CA Franchise Tax Board and the CA Attorney general, create bylaws and define a governance structure. The registrations have commenced, which allows us to open a new bank account for the Foundation, so the donated funds can be transferred to the Foundation early in the New Year. I thank Stu Williams and Roy Hodgkinson for driving this process towards completion in record time.

The GoFundMe organization only transfers online donations to one payee or organization, so we cannot make payments to the Sirs who are fire victims directly from that online account. Instead, we have set up the Foundation as the recipient of the donated funds and we will make grants to the affected Sirs from the Foundation bank account. We will appoint a local team in the Chico area to offer

We will appoint a local team in the Chico area to offer advice to the Foundation on the disbursement of the collected funds.

The main business of the initial Board Meeting for the Foundation will be to approve the Bylaws and Officer appointments. We will then discuss and approve procedures for distributing the funds to the Sir Camp Fire victims. After completing these steps we can officially announce the start of Foundation operations to the membership of SIR, probably mid to late January.

Revised Form 27

Because your State Board has deleted the category of 'Inactive' members we needed to edit the Form 27 to take this into account. The new Form 27 and instructions (Form 27A) have been posted on the State website at http://sirinc.org/sirforms/

Please discard your old Form and use the new Form 27 dated 12/17/2018.

Raffles

Raffles are a controversial topic, but as State Rule 45 states "No Branch or Branch Activity shall conduct a raffle or lottery in violation of California State or Federal laws. (New 11/18/03)". We should remember that under CA law nonprofit organizations are required (pursuant to California Penal Code Section 320.5) to expend a minimum of 90% of the raffle gross proceeds to directly conduct beneficial or charitable activities. There is an exemption for sports teams which allows (under very specific conditions) a 50:50 split, but this is not applicable to non-sports teams. SIR State advice is to **NOT run raffles**.

Focus on Activities to Improve Recruiting

We have seen some Branches successfully using Social Media such as Facebook, Patch and NextDoor to promote and advertise their upcoming (or recent) Activities. This can include the speaker at their luncheons too! Use this opportunity to invite guests to activities which they enjoy before they attend their first luncheon. Show the guest the benefits of the activities your Branch offers – it is a potent selling tool as they can start making New Friends immediately.

I have had an interesting year serving as your President. It has been an honor, and privilege, to visit your Branches to make Honorary Life Membership awards. The men who earned these awards are the true heroes of our organization, but there are so many others who volunteer at all levels who rarely gain recognition. Without their input, the organization would cease to exist. My final suggestion of the year to every Branch is to find some way to recognize some members at every meeting. Give some appreciation and who knows, it might result in more volunteers! Your Branch may already be doing this, in which case a short article in Happenings telling of the benefits might help Branches which are doing less than yours.
