SIR Minutes of Branch 159 Executive Committee Zoom Meeting August 13, 2020

The meeting opened at 9:00 am utilizing the Zoom meeting format. BEC members present were Little Sir Bruce Corwin, Secretary Vic Froehmer, Assistant Secretary Robert Scott, Treasurer Brian Nicholson, and Assistant Treasurer Brett Bayley. Directors present were Gary Morgan (2020), Steve Chase (2021), Pete Openshaw (2021), Tom Simpson (2022), and John Crawford (2022). Excused from the meeting were Big Sir Dell Kerns, Roger Deal, and Ron Wilson. Assistant Secretary Robert Scott announced that a quorum was present (10 of 13).

Next, a review of the July 9th meeting minutes was conducted. Steve Chase moved that the minutes be approved as presented, and John Crawford seconded the motion. The minutes were approved unanimously.

Pete Openshaw suggested that a new list of members be provided for the callers because the old list does not include any of the new members. It was proposed that members be contacted at the beginning of September to determine their wellbeing and to inform them we will not be having the scheduled September meeting.

Next, Brian Nicholson reviewed the Monthly Cash Report (Form 28). Cash on hand was pronounced to be \$9,074.02. It was stated that there was minimal financial activity during the month because we are not meeting. The only activities were assessments received from new members and a bill for the catalog of our members.

In regard to membership information, John Crawford reviewed the July Membership Report. The report indicated we have 202 members, four new members pending BEC approval, and five new members to be inducted at our next meeting. These members have been approved by the Branch Executive Committee and have paid their annual assessment. It was decided that the installation of new members would occur at our next regular luncheon meeting so a traditional process could be provided.

The final business item concerned Bruce representing Branch 159 at a state meeting. He requested and received permission to vote on behalf of our branch.

The meeting was then adjourned at 9:35 am.
