
I hope you all have a great start to the new year. Looking forward to 2023, I expect that we'll move toward a more Covid free environment, which should free things up for 2023 even more.

#### SIR Minutes of Branch 159 Executive Committee

#### December 8, 2022

The meeting opened at 10:15 am at Pardini's Restaurant. BEC officers present were Big Sir Stuart Poytress, Treasurer Brian Nicholson, Assistant Treasurer Steve Chase, Assistant Secretary Brett Bayley, and Secretary Robert Scott. Directors present were John Crawford (2022), Javier Rodriguez (2023), and Mark Isonio (2024). Stuart Poytress proclaimed we had a quorum (8 of 12) and opened the meeting.

Next, a review of the November 10, 2022 meeting minutes was conducted. Brett Bayley moved that the minutes be approved, and Steve Chase seconded the motion. The minutes were approved unanimously.

Based upon inquiries during the calls to members, we have ordered 89 lunches for today's meeting. In addition, it was reported we still need members willing to fill two vacant caller positions.

It was then announced that there would not be a program for today's meeting.

Next, the Monthly Cash Report (Form 28) was reviewed. Treasurer Brian Nicholson reported the financial activities during November 2022 involved several significant transactions. In regard to General Accounts, we received \$1,375 during November from Branch 159 member assessments for 2023 and disbursed \$115 for wine and candy we distribute to members at each luncheon. The report also stated we actually received a net gain for luncheon costs because of a credit from Pardini's for the October luncheon. Consequently, the cash balance at the end of November was \$11,339.75. Brett Bayley moved that the report be approved and Steve Chase seconded the motion. The report was approved unanimously.

In regard to membership information, John Crawford first reviewed the November Membership Report. The report shows today will be the 332 th meeting of our branch. The report shows we inducted one new during November to bring our total membership to 190 members. However, John indicated that the BEC will approve the termination of 4 members when they accept the November Membership Report. Consequently, despite adding 15 new members this year, we have 17 fewer members than we had at the beginning of January 2022. Next, John reviewed Form 27 that supported the Membership Report.

He mentioned our November luncheon attendance of only 87 members. Steve Chase moved and Brett Bayley seconded the motion that both membership reports be approved. There was unanimous approval. At this point, the BEC acknowledged John Crawford for all of his years of work maintaining our membership records and other administrative activities..

Under the heading of Old Business, two items were mentioned. First, the office of Treasurer will be filled by Bruce Corwin until Garry Elliott and Keith Lovgren become familiar with the duties of the position. Second, Treasurer Brian Nicholson reported that 95 members have paid their 2023 membership assessment leaving 93 remaining to be collected.

New Business discussions also concerned two topics. The BEC felt it might be beneficial to remind the members during our luncheon that a new roster/directory would be published in March of 2023, and now would be the time to review individual entries to determine if their current entry is accurate. The second item involved an idea to revise the distribution of our luncheon drawing. Brian Nicholson moved and Brett Bayley seconded the motion that the total amount collected would be distributed each month. The motion passed unanimously.

The final action concerned microphone time at today's luncheon. It was determined that Duke Marshall, Brian Nicholson, and Fred Martinez wanted to address the group.

There being no other business, the meeting was adjourned at 10:38 am.

We began the past month with a cancellation at Eagle Springs due to weather. The next stop was a Shamble at Madera Muni and the team of Russ Anderson, John Shertenlieb, Brett Bayley, and Bob Rathburn won by 7 strokes at 112. In the two closest to the pin competitions on hole number 6 Brett Bayley won by an inch at 3' 4" over Bill Eigenman and Bob Mattson took first on hole 15 at 4' 10"". Now moving on to Dragonfly for the final 4man Novelty event of the year the team of Jeff Shahbazian, Garry Elliott, John Briceno, and Jeff Boatman took the field at 218 by 6 strokes. In the four closest to the pin competitions on Hole 3 Robert Ying placed first at 2' 1", on Hole 5 Charlie Amasalian took first at 6' even, on Hole 12 Loren LaBaron won at 9' 6", and on Hole 16 Russ Anderson placed first at 7' 3". In the single round Gross competition Flight 1 was won by Russ Anderson with a 71, Flight 2 was won by Duke Marshall at 70, Flight 3 was won by Rick Ransom with a 71, and Flight 4 was won by Jeff Boatman with a 71. In the best 3 out of 4 Gross rounds over all four Novelty tournaments the winner in Flight 1 was Russ Anderson at 200, in flight 2 the winner was Brett Bayley at 205, the winner in Flight 3 was Gary Smith at 215, and the winner in Flight 4 was Jeff Boatman at 214.

## 1. POLICIES GENERAL-Continued Policy 10. SIR AWARDS/CERTIFICATES - Continued

3. "I'm Doing My Part" Award- This lapel pin award is for Branches to provide special recognition for their members that have not earned the level that a DSA or HLM award requires but have been contributing to the success of the Branch. Branches shall establish their own individual criteria for candidate selection and approval but keeping in mind the need to recognize all members that volunteer as it's these members that a Branch cannot survive without.

There is no limit to the number of these awards presented within a Branch. State initially supplied 1,000 of these award pins across all the Branches and with the announcement of this new award program will supply another 500. Additional award pins may be ordered by Branches using Form 21.

- <u>4. Presidential Awards</u> Senior Sir, Super Senior Sir, and Century Sir Certificates are milestone-related awards for members who have reached the ages of 90, 95, and 100 respectively. A Branch may offer these awards, using instructions found under Forms (Forms 6A, 6B and 6C) to print their own certificates without having to involve State as previously required.
- <u>5. President's Appreciation Certificate</u> The President's Appreciation certificate has been discontinued and replaced with the Distinguished Service Award.
- <u>6. Certificate of Appreciation</u> A Branch Executive Committee or a State Officer may obtain a Certificate of Appreciation (Form 7) and issue it to guest speakers and other members under the signature of the Big Sir.



#### The Distinguished Service Award Silver Lapel Pin

- 2. Distinguished Service Award (DSA) This "Silver Lapel Pin" award is the 2nd highest award in SIR, to recognize exceptional/extraordinary service at the Branch and/or State levels. This award is to provide a level of recognition for their members that have not earned that which an HLM award requires but have been highly contributing to the success of the Branch an have:
  - been a member for a period of 3 years or more.
  - · clearly earned it through exceptional and extraordinary service.
  - · steps forward whenever the need arises
  - would be recognized by his peers to have earned it

#### New California Traffic laws effective January 1, 2023

The laws include:

SB 1472 expands the criteria for "gross negligence" to include drivers involved in sideshow activity, exhibition of speed or speeding over 100 mph resulting in a fatality.

AB 2000 includes parking lots and off-street parking facilities as locations where it is a crime to engage in speed contests, exhibitions of speed or sideshow activities.

AB 2147 prohibits police officers from stopping pedestrians for certain pedestrianspecific violations such as crossing the road outside of a crosswalk, unless there is an immediate danger of a crash.

AB 1946 requires the CHP to work with other traffic safety stakeholders to develop statewide safety and training programs for electric bicycles.

AB 1909 provides increased protections for bicyclists by requiring vehicles passing or overtaking them in the same direction to move over to an adjacent traffic lane if one is available, or slow down and only pass the bicyclist when it is safe to do so.

SB 1087 intends to help reduce catalytic converter theft by requiring recyclers to keep documentation such as the year, make, model and copy of the vehicle title from which the catalytic converter was removed.

SB 960 removes the requirement that peace officers, including trainees, must be citizens or permanent residents of the United States.

AB 1732 authorizes law enforcement agencies to request the CHP to activate a "Yellow Alert" for fatal hit-and-run crashes. The law also encourages local media to disseminate the information contained in a Yellow Alert.
