Musings from the Golf Wizard

Dear Wizard,

Thanks for last month's clarification of a ball deemed out of bounds. So I drop a ball in the near vicinity of where it disappeared and I will be hitting 4 on my next stroke. This should save a lot controversy plus a lot of time. See? I'm not as dumb as I am smart. However, what do you mean by *near vicinity*?

Now, here's a related situation that is often debated. The drive of player #4 (not me) lands clearly on the fringe of the fairway. Everyone agree as to its possible resting site and after a few minutes of looking his buddies also agree the *ball should've been found and no penalty should be assessed*. "Just drop a ball where you think it should be," he was told. Happily, he did. Wizard, is there something wrong with that? Your old, old buddy.

Dear Hazard:

It seems as if you have more situations that come up when you play than the average bloke. I guess I'm glad to hear from you again.

You ask about "near vicinity". This special SIR rule which applies when no provisional was hit and the ball is never found, or is found to be out of bounds. If the ball is out of bounds, vicinity means within two club lengths, no closer to the hole, of where your group guesses the ball went out of bounds. If the ball is lost, vicinity means within two club lengths, no closer to the hole, of where your group guesses the ball was lost. Not an exact science but I hope this helps.

The situation you describe about "the ball should've been found and no penalty should be assessed" is called a LOST BALL and you drop a ball within two club lengths of where the group thinks it should be, no closer to the hole, and you are hitting your fourth!

Incidentally, I have proposed, but do not have sufficient support yet, a variation called the "imaginary provisional". If my proposal is ever approved, in the situation above, with the ball lost, and no provisional hit, each of the other three members of the group would each mentally picture the person whose ball is lost back on the tee hitting his/her provisional. Each would then picture the ball hitting the ground and then rolling to a stop. They would then each put a tee into the ground representing the resting place of the their "imaginary provisional". Then the exact center of the triangle outlined by the three tees would be calculated, and the person whose ball was lost would be instructed to drop within two club lengths of this spot, no closer to the hole. He/she would be hitting four. Simple? At the moment there are only two remaining problems with this method:

- 1. You would have to have someone in the group able to rapidly calculate the center of a triangle, or have ready access to such a person from outside the group. Perhaps each group could carry a personal computer which had the formula?
- 2. This method would no work with a threesome as you would have only two tees marking "imaginary provisionals" by disinterested parties, and everyone knows you cannot make a triangle from just two points.

We can only hope that my proposed method will soon be adopted!

Branch 116 Golf Leader Board as of May 5, 2004 (Boundary Oaks)






